GSK Pentavalent Vaccine

- After immunogenicity data presented to ACIP, Bexsero (comparator) label changed from 0, ≥ 1 month to 0, 6 months
- Longer intervals between vaccine doses associated with higher immunogenicity
 - As a result, pentavalent now has comparatively lower immunogenicity than MenB
- Some data points in label have also been updated
- WG members voiced need for ACIP to review updated data in consideration of vote, although WG recommendation has not changed
