Author names have been provided in the format shown in the following example. Only the highest academic degrees (not certifications) have been listed, at the master’s level or higher. When an author has two degrees at the same level (e.g., MD, PhD, or MS, MPH) both have been listed. Degrees have been followed by a superscripted numeral corresponding to the affiliation. Numerals are listed in sequential order. Ex.: “Karlyn D. Beer, PhD <sup>1,2</sup> ; Julia W. Gargano, PhD <sup>2</sup> ; Preeta K. Kutty, MD <sup>3</sup> ; Elizabeth D. <p>Footnote “callouts” have been indicated in the text with the correct sequential symbols. Footnotes are grouped as “plain text” endnotes beneath the references in the submission. No reference manager or footnote/endnote programs or Word features are included in the submission.</p>	<input type="checkbox"/>
<p>Tables have been submitted in the formats described in the Instructions for Authors. Tables can be embedded in the text.</p>	<input type="checkbox"/>
<p>In tables, confidence intervals have been headed with (95% CI), and parentheses also placed around each value in the column. Footnote symbols are placed sequentially in the table, beginning with the title and then moving from left to right, row by row in the table.</p>	<input type="checkbox"/>
<p>Each table and figure has a “complete” title, such that a reader can have a general understanding of what the data represent without reading the text.            Ex.: “TABLE 1. Waterborne disease outbreaks associated with drinking water (N = 32), by state/jurisdiction and month of first case onset — Waterborne Disease and Outbreak Surveillance System, United States, 2011–2012”</p>	<input type="checkbox"/>
<p>Figures have been submitted in the formats described in the <a href="#">Instructions for Authors</a>. Figures should be submitted in a separate file and not embedded in the text. Maps have been submitted in one of the proper editable formats.</p>	<input type="checkbox"/>
<p>For figures, all footnote symbols have been placed in the title. New process requirements do not permit placement of footnote symbols within figures</p>	<input type="checkbox"/>
<p>Bar and line graphs should have linked, underlying data tables.</p>	<input type="checkbox"/>
<p>Files created by vector programs are best for accurately plotting and maintaining data points. <i>MMWR</i> is unable to use file formats native to statistical software applications to prepare figures for publication; most statistical software programs allow users to save or export files in digital vector formats.</p>	<input type="checkbox"/>
<p>Acceptable file formats are Adobe Illustrator (.ai), .eps, PowerPoint (.ppt), Excel (.xls), .wmf, Word (.docx editable not pasted into), .svg, and .pdf.</p>	<input type="checkbox"/>
