In preparation for the future release of the 2022 HAI national baseline, we are excited to announce a new training opportunity. Join us on August 20th and August 21st to learn more about the impact that the 2022 HAI Rebaseline may have on your facility or Group's Standardized Infection Ratios (SIRs). Presenters from NHSN's Acute Care Analytic Team and Statistics Teams will walk through some of the early, high-level analyses that CDC has conducted to understand the impact of the new baseline at a national level.

In addition, presenters will provide examples of methods to compare and interpret SIRs from both the 2015 and 2022 national baselines and will discuss how to use SIRs under both baselines to tell the story of your hospital's HAI data. Attendees will be able to ask questions using the virtual Q&A functionality.
