journals; the employees whose livelihood codepends in coordinating all systems; & then the community whose self health interest is at stake without claiming any secondary gains of altruism or scientific knowledge. It shocks me to see how incomplete the data base of subjects registered is, given that the goal of discovering epidemiologic short & long term effects of 9/11 on those most exposed. Their scope of including treatment programs is laudible though their closed registry is a disservice. I lived here all that time, & was unable to join the registry because of red tape. I know that none of my neighbors was enrolled & I doubt that the majority of residents living below Canal St. were solicited to join or even knew about its existence. The registry site states: "From 2003 to 2004, 71,437 people enrolled in the WTC Health Registry by completing an initial survey. Among all enrollees on 9/11:

More than 43,000 were building occupants and passers-by in Lower Manhattan south of Chambers Street, including 4,000 survivors of the collapsed WTC Towers.

Close to 15,000 lived south of Canal Street in Lower Manhattan.

Approximately 2,500 were children and staff in schools (pre K-12) south of Canal Street.

About 31,000 were rescue, recovery and cleanup workers and volunteers at the WTC site, the Staten

Island recovery operation site or on the barges "
Since downtown residents, most of whom were not evacuated, certainly were exposed to toxic acrid fumes for a much more prolonged period of time than the transient "building occupants & Passers-by", their 20% composition under-represents a significant portion of the population at risk which is under study. By omitting this group, the data will be skewed as to under recognition of risks. What is the actual total population of residents living below Canal St. from 9/01 to the present? I propose that a new comprehensive data collection campaign be conducted to canvas this cohort by mass mailing a brief physical & mental symptom questionnaire to be delivered to everyone in the correct zip codes by mail. I can help draft the questionnaire.

Let me know what you think of this idea.

Hi Catherine.

I read about the Zadroga Act & upcoming forum in Downtown Express. I met you last year at WTC Health Comm. meetings when I volunteered with Public Health Dept as a Pulmonary Physician.

I would like to note my concern that the Tribeca neighborhood is not being monitored for cancer incidence. I suspect there is an increased incidence especially of lung cancer since 9/11 & epidemiologic surveys are not being done. My husband who was a non-smoker was diagnosed with Stage 4 lung adeno carcinoma 1/09 & died 4 months later. No one in his family, despite being heavy smokers, ever had cancer. I can't help but suspect a causative relationship with heavy exposure to toxins released from the WTC collapse.
