2) Are the supplies to neutralize the spill in the spill kit? What are they specifically?

3) What happens to the automated pumps when finished with them?

4) What if you are pregnant or trying to conceive... should you work with this agent?

5)What training and how often should it be done?

The bonus sheets were well done but obviously redundant in many areas. I don't know if this can be changed but maybe it doesn't need to be. Also not sure why you have "material" in parens. It is also unclear like on PPE what respiratory equipment is needed and you refer to the supplier or safety manger. Not sure this is appropriate and believe this should come from NIOSH. Same for ANSI standard on the PPE form...what ANSI standard? Also what is the S100 on PPE form.

One thing that is glaringly absent is anything about health/medical surveillance...what should be done for this?
