I am the daughter of Lt.Col.[(ret)(Deceased)]

. He was discharged (with Honors) @30% medical work related cancer from Hodgkin's in 1963. This was directly related to his Intelligence Assignment which posted the entire family to the Philippine Islands for 24 months (Hardship duty-Max stay was to be 18 MOS) where he accomplished his orders "To get the 35 year good will pact," prohibiting the Philippines from suit against the US for any reason signed by President MagSiSi. When CDC determined AlLD, "Project Bravo" (detonation of Hydrogen Bomb, 10,000 x more powerful than the atomic bomb dropped on Hiroshima), on the Bikini Atolls was still classified as Top Secret. Thus, he received Plasmaphoresis for 3 years which gave him another 13 years of life, which ended in Lung Cancer. My eldest Brother, (NATIONAL MERIT SCHOLAR AND PHYSICIST, (disabled) died at age 44 of sepsis of abdominal cavity, and heart failure due to antibiotics given to treat sepsis. suffered from exposure. Dad also taught a course on radiation at the Pentagon and brought home a lead thermos with a radiated furry animal in it. The class was so top secret that he was required to bring the cylinder home, where he stored it in our basement fridge where our soda was stored. He did tell us not to touch it, so of course we opened it and looked in to see the horror inside. Dad had to have new front teeth growing sideways (90o) extracted from his jaw. So far, insurance has denied all care. Can you help us (military dependents who had no work contract with the Federal Government, but are suffering as a result of Love for and Loyalty to our Country)? My Father was head of

Military records proving all statements can be provided upon request. I pray that our country will give some recognition to the children who have suffered all their lives without knowing why or what was happening to our bodies. Radiation necrosis of teeth have required removal, bone tissue is warping as a result of dentures. The list of body system problems and the MD Dxs can also be provided. Dad, & I have identical problems documented in our medical records. Thank you for your time and attention to my request. Dad's DNA had been changed prior to birth of , who was born with hips w/out cup to hold hip bones together.
