- Prepare a working matrix of contractor findings on PROC 0092.
- Prepare a one-page workup on OTIB 0012 findings for Work Group consideration for addition to the matrix.
- Review NIOSH response to OTIB 0017-06 and report position to Work Group.

- Discuss OCAS OTIBs 6 and 7 to determine if they need to be reviewed as "documents modified as a result of review" or as new documents.
- Conduct further clarifying technical discussion on OTIB 0023 and report result to Work Group on the November 7 conference call.
