Security experts from the [Cybersecurity and Infrastructure Security Agency \(CISA\)](#) will share their insights on conflict prevention

strategies and considerations to enhance safety and security and increase personal resilience in health care and public health communities. Speakers will also introduce tangible ways to identify and mitigate incidents of targeted violence. Participants will learn to recognize the warning signs of someone on a path to violence and

CDC is extending the March 29 deadline for Public Health Crisis Response (PHCR) recipients to submit their next quarterly progress and fiscal reports for their 2020 COVID-19 response funding. The new deadline is **Tuesday, April 30**. CDC is providing recipients with additional time due to REDCap system delays and the upcoming 2024 PHEP application deadline.

SNS to Host April Office Hours on Inventory Management and Tracking System

The next monthly Strategic National Stockpile (SNS) Office Hours will be held from **4 p.m. to 5 p.m. EDT** on **Wednesday, April 17**. The one-hour national call for state, local, tribal, and territorial (SLTT) partners will focus on the Inventory Management and Tracking System (IMATS), a secure Web-based software application developed to help SLTT public health agencies manage information regarding their medical countermeasure inventory.

During this session, SNS technical experts will provide an overview of the free IMATS tool, recent and pending updates, and how the tool can be used to meet both everyday and emergency inventory management needs.
