

## New CDC Preparedness Field Assignees Now on Board in Eight Jurisdictions

CDC continues to expand the PFA program to meet the growing preparedness and response needs of PHEP jurisdictions. CDC initiated a phased approach to strategically grow the PFA program, initially adding 11 new PFAs in 2022 to provide boots-on-the-ground support to state and local preparedness programs and provide early-career professionals with additional field experience in state and local emergency preparedness and response. With the assignment of a senior PFA to Guam in November, there will now be 29 PFAs supporting 28 jurisdictions. As graduates of CDC's Public Health Associate Program, PFAs are a vital link in the public health preparedness workforce pipeline and help to fill state-level staffing and preparedness capacity gaps.

## CDC Updates Recommendations for Hepatitis C Testing among Perinatally Exposed Infants and Children

The elimination of hepatitis C is a national priority. During 2010-2021, hepatitis C virus (HCV) acute and chronic infections increased in the United States, consequences of which include cirrhosis, liver cancer, and death. In 2020, because of continued increases in HCV infections in the United States, CDC released universal screening recommendations for adults, which included recommendations for screening of pregnant persons during each pregnancy. A new Morbidity and Mortality Report introduces new CDC recommendations for hepatitis C testing to identify more perinatally infected children and link them to care.
