



RPE Program Timeline

2002-2012

RPE moves to CDC & focus on primary prevention is incorporated into programming



1994-2001

Authorization of the Violence Against Women Act (VAWA; 1994)

RPE first initiated through the DOJ



2012-Present

VAWA reauthorized in 2013, and most recently in 2022

Focuses on best available evidence and community/societal prevention

Purpose:

The aim of this NOFO is to prevent sexual violence (SV) perpetration and victimization by increasing protective factors and decreasing risk factors. We aim to achieve this through a public health approach of implementing and evaluating comprehensive strategies based on the best available evidence and Indigenous Knowledge.


- As authorized by the Violence Against Women Act (2022) and 34 U.S.C. 12291, only Tribal Sexual Assault Coalitions are eligible to apply.
- You must state that you are a Tribal Coalition and include your coalition's name in the project abstract.

Funding Information

- Total Project Funding: \$3,600,000
- Total Period of Performance: 4-year
- Expected Number of Awards: Up to 10 Tribal Sexual Assault Coalitions
- Expected total program funding per budget period: \$900,000
- Maximum recipient funding per budget period: \$90,000

Focus Areas	Description	Examples of approaches with existing evidence
Focus Area 1: Strengthen Economic Supports	Employment, stable housing, financial stability, and food security are important protective factors for women's risk of SV victimization. Policies and programs that work to improve financial stability can also reduce the risk factors associated with SV victimization.	<ul style="list-style-type: none">• Strengthen Household Financial Security• Family-Friendly Workplace Policies
Focus Area 2: Create Protective Environments	To achieve population level reductions in SV rates, SV prevention should include community and societal level strategies that change community characteristics, so they are safe, healthy, and protective. Community and societal level prevention strategies go beyond changing individual attitudes, beliefs, and behaviors, and focus on modifying community structures, social norms, environment, and policies.	<ul style="list-style-type: none">• Improve School Climate and Safety• Improve Organizational Environments• Reduce Exposure to Community-level Risks
Focus Area 3: Promote Social Norms that Protect Against Violence	Approaches that focus on changing the social norms (group-level beliefs and expectations of members behavior) related to the acceptance of violence and restrictive gender norms of priority groups have the potential to reduce rates of SV perpetration and victimization.	<ul style="list-style-type: none">• Bystander Approaches• Men and Boys as Allies in Prevention

Expected Outcomes

- Result in increased implementation of Sexual Violence (SV) primary prevention strategies and programs that work to reach communities with increased risk for violence.
- Help Tribal SA Coalitions strengthen and build the infrastructure to decrease SV perpetration and victimization rates in tribal communities.
- Reduce disparities in SV by addressing associated inequities in Indigenous Determinants of Health (IDOH)



This NOFO supports **meaningful engagement, coordination, and capacity building** across tribal organizations and partners, including partners with expertise in SV and health equity/IDOH as well as other CDC-funded programs.




Post Award Support and Deliverables

CDC Monitoring

- Monitoring activities include routine & ongoing communication between CDC & recipients, site visits, & recipient reporting (including work plans, performance, & financial reporting).
- Post-award grant monitoring & reporting activities will include, but are not limited to:
 - Participating in regular calls with Project Officers
 - Monitoring recipient progress in achieving the outcomes
 - Establishing a process for monitoring continuous program improvement over time

Purpose/Summary

The purpose of [this notice of funding opportunity \(NOFO\)](#) is to prevent sexual violence perpetration and victimization by increasing protective factors and decreasing risk factors. We aim to achieve this through a public health approach of implementing and evaluating comprehensive strategies based on the best available evidence and Indigenous knowledge.

The goal of this NOFO is to fund up to 10 tribal sexual assault coalitions to implement and evaluate evidence-informed and Indigenous knowledge-informed strategies that address Indigenous Determinants of Health (IDOH) across Indian Country.

Our goal is to help NOFO recipients advance health equity through prevention efforts. To do so, we require NOFO recipients to:

- Build infrastructure for sexual violence prevention.
- Develop a tribal sexual violence Primary Prevention Action Plan.
- Implement sexual violence prevention strategies that advance health equity.
- Foster meaningful engagement and coordination with state/territory/tribal health departments and sexual assault coalitions.
- Use data to inform action.

The strategies and activities are expected to:

- Increase implementation of sexual violence primary prevention strategies and approaches that work to reach communities with high risk for violence.
- Support Tribal Sexual Assault Coalitions to strengthen and build the infrastructure to decrease sexual violence perpetration and victimization rates in tribal communities.
- Reduce disparities in sexual violence by addressing associated inequities in Indigenous Determinants of Health.
